2. The use of the electronic service

The service allows to view published information on the programs, consultancy, advisory and educational services, support, conditions and mechanism of its obtaining, regional availability and contact points.

2.1. Orientation on the Electronic Services Portal

The agenda of electronic service is accessible through:

- Thematic blocks
- List of electronic services
- Searching by term / phrase
- Filtering by selected request

2.2. Service detail

After selecting the desired service, the system displays a page with a detailed description of the service accompanied by additional information on administrative charges, required attachments, information for whom the service is intended and with a brief manual.

2.3. The use of the service

The service provides the following options:

- Access to the published information – public authorities have the opportunity to inform on particular agenda on the ES Portal of the MoE SR.

3. Access to published information

The organization publishes information for public on web portal. The service displays published information in a form of a list of documents. Published information are sorted by date - currently valid documents are shown in the "Current data" folder and the documents validity of which disclosure was completed are shown in the "Archive data".

By clicking on the link of the document, the system will offer the option to download the document or to view it. Information may be disclosed in a variety of document types - doc, html, etc.

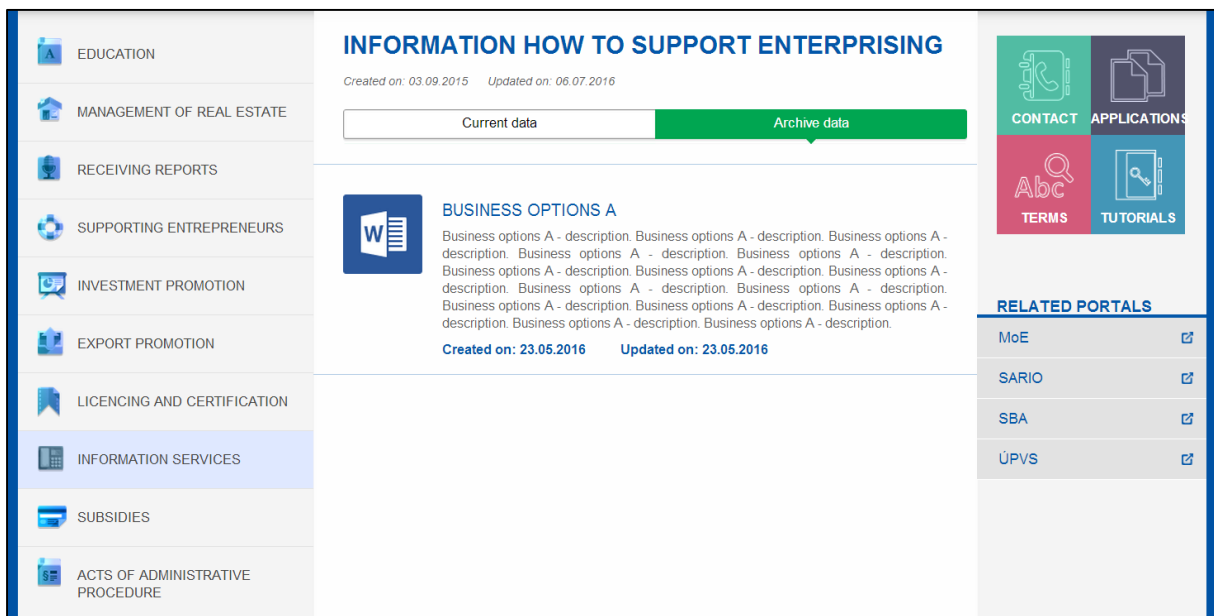


Figure 3 - Display of the information in the form of document

Electronic Services Portal contains information which serves for faster execution of your agenda and answering of any questions.

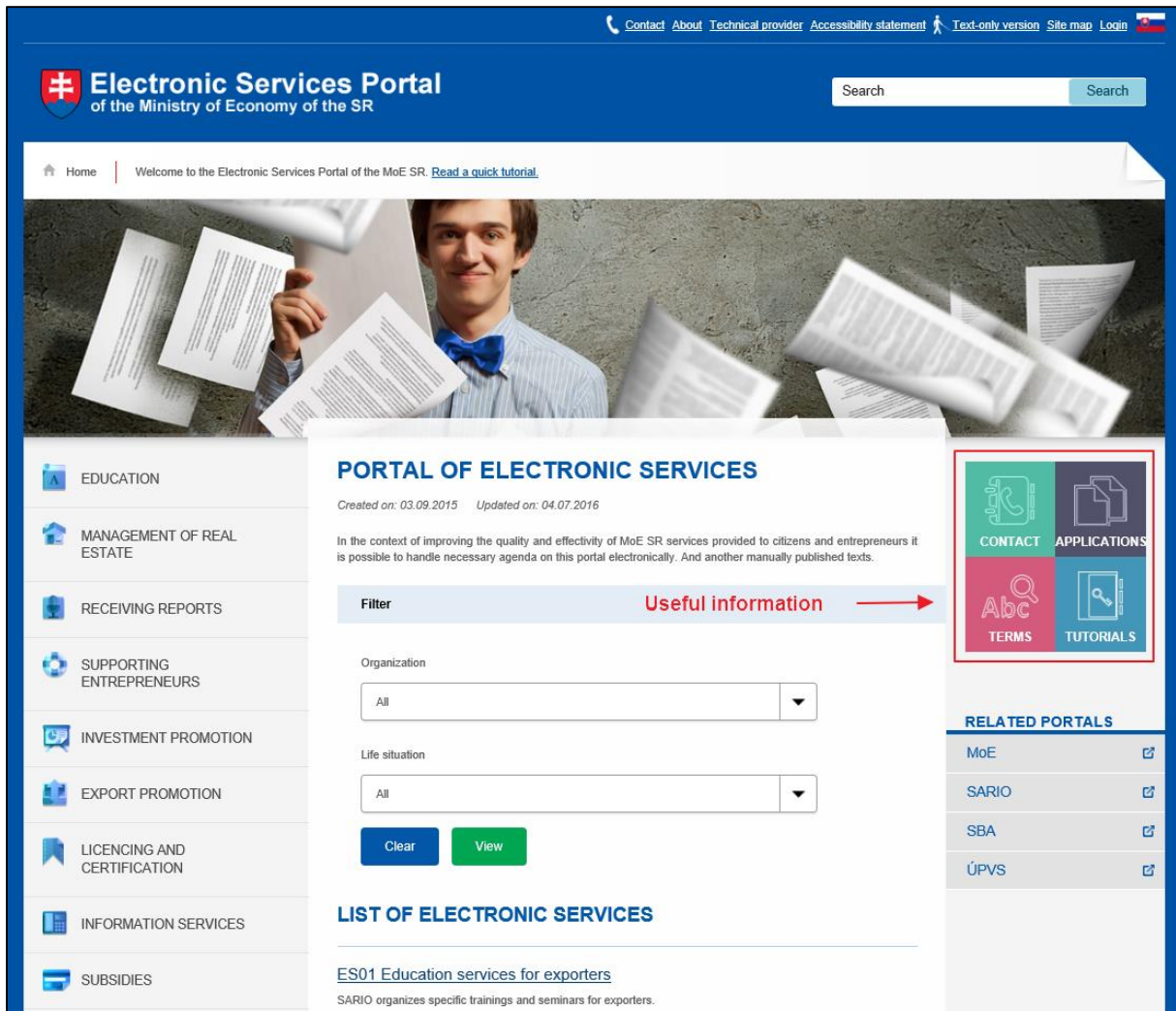


Figure 4 - Useful information
